EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989

Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, as amended, I, Mahinda Rajapaksa, Minister of Finance, do by this Order declare that:-

- (i) the rate of Excise duty specified in the Column IV applicable on corresponding articles specified in Column I of the Schedule A hereto, shall amend the rate specified in Column IV on the corresponding articles of the Schedule I of the Extraordinary *Gazette* Notification No. 2113/9 dated March 05, 2019, as amended issued under the Section 3 of this Act with effect from April 23, 2021;
- (ii) amend the Schedule II of the Extraordinary *Gazette* Notification No. 2113/9 dated March 05, 2019, as amended issued under the Section 3 of this Act as set out in the Schedule B with effect from April 23, 2021.
