

Standing Cabinet Appointed Procurement Committees (SCAPCs)/Cabinet Appointed Procurement Committees (CAPCs)/Cabinet Appointed Negotiating Committees (CANCs)/ Cabinet Appointed Consultants Procurement Committees (CACPCs)

In keeping with the changes of ministerial portfolio, until a formal arrangement is made the Cabinet of Ministers at its meeting held on 21.11.2018 has given approval for the following proposals on the functioning of the Standing Cabinet Appointed Procurement Committees (SCAPCs), Cabinet Appointed Procurement Committees (CAPCs), Cabinet Appointed Negotiating Committees (CANCs) and Cabinet Appointed Consultants Procurement Committees (CACPCs) in order to complete the ongoing procurements as scheduled.

- Hand over the ongoing procurements of the Ministries, which are no longer exist due to the recent change in ministerial portfolio to the appropriate Ministry to which their functions are assigned to. (The remaining activities in the procurement process should be carried out by the SCAPC of the new Ministry).
- Continue the service of the former Secretaries who have already been appointed as the Chairman/Member of the SCAPC and do not hold a Secretary post and still in the public service.
- Continue the service of the retired public officials who have been appointed as members of the CAPCs in the Ministries where the portfolios have not been changed.
- Make a formal request to the Department of the Public Finance to appoint/reconstitute the SCAPCs/CAPCs/ CANCs and CACPCs, as required in case where there are situations which do not fall under the above situations.
