"Activating the sale of Agro products through the intervention of the Government which was inactivated at divisional/national level due to Island wide measures taken to prevent the spread of Covid-19 Virus"

This refers to the Cabinet Decision taken on 22.04.2020 regarding the Cabinet Memorandum No. 20/0742/217/038 and dated 22.04.2020 submitted by the Minister of Mahaweli, Agriculture, Irrigation and Rural Development on "Activating the sale of Agro products through the intervention of the Government which was inactivated at divisional/national level due to Island wide measures taken to prevent the spread of Covid-19 Virus"

Accordingly, request shall be made to the Department of National Budget for provisions required for expenses that cannot be settled by using imprest provided by the Treasury to District Secretaries and other institutions to conduct the purchasing process of agro products and actions will be taken to allocate such provisions.
