Providing Treasury Monthly Accounting Statements (Printouts) Through the Internet

Your attention is drawn to the State Accounts Circular No. 173/2004 issued for providing Treasury Monthly Accounting Statements through the internet.

- 02. It has been decided to provide the facility to obtain Treasury Monthly Accounting Statements from August 2019 onward through New CIGAS for all Government Ministries, Departments, Special Spending Units and District Secretariats.
- 03. Following new Treasury Monthly Accounting Statements for your institution under new numbers from August 2019 can be obtained through www.newcigas.treasury.gov.lk (Main Menu→Treasury Monthly Accounting Statements)
- 04. The same usernames and passwords already allocated to authorized officials of your institution under New CIGAS online Web Interface can also be used to obtain the relevant Monthly Accounting Statements.
