<u>Procurement of Works up to Rs. 50 Million from Regional Contractors under Domestic</u> Funds

Sub paragraph 3.3 under paragraph 03 and paragraph 04 of the Public Finance Circular No. 04/2016(ii) dated 08.05.2019 issued on the above subject is amended as follows.

" 3.3 In order to promote fair competition among the regional contractors, previously specified Construction Industry Development Authority (CIDA) grade for respective financial threshold are changed as follows:

Estimated Value of work to be performed under the procurement	CIDA Grade
(excluding VAT and other taxes)	
Below or equal to Rs. 2,000,000.00	C9 and C8
Above Rs. 2,000,000.00 and below or equal to Rs. 5,000,000.00	C8 and C7
Above Rs. 5,000,000.00 and below or equal to Rs. 10,000,000.00	C7 and C6
Above Rs. 10,000,000.00 and below or equal to Rs. 25,000,000.00	C6 and C5
Above Rs. 25,000,000.00 and below or equal to Rs. 50,000,000.00	C5 and C4

- **04.** When bids are invited (Invitation for bids) you may insert the method of procurement as follows.
- "Bidding will be conducted through National Competitive Bidding (NCB). Since the Estimated Value of Work to be performed under this procurement (excluding VAT and other taxes) is below Rs. 50 Mn., regional preference and CIDA grade preference shall apply as stipulated in Public Finance Circular No. 04/2016 (iii).""

- 02. In the provisions of the Public Finance Circular No. 04/2016(ii) dated 08.05.2019 other than above shall remain unchanged. Further, this circular shall be considered with the paragraph 3.1 and 4 in the Public Finance Circular No. 03/2020 dated 09.10.2020.
