EXCISE (SPECIAL PROVISIONS) ACT, No. 13 OF 1989

Order under Section 3

BY virtue of powers vested in me by Section 3 of the Excise (Special Provisions) Act, No. 13 of 1989, I, Mangala Samaraweera, Minister of Finance and Mass Media, do by this Order,

- a. amend Item No. 1(b) and 1(c) of the Schedule II of the Order made under that Section and published by the *Extraordinary Gazette* Notification No. 2044/32 dated November 09, 2017 by substitution of the following Schedule A hereto ; and
- b. amend Item No. 02 and 03 of the Order made under that Section and published by the *Extraordinary Gazette* Notification No. 2047/25 dated November 28, 2017 by substitution of the following Schedule B hereto.

This Order shall come into effect from February 16, 2018.

03.	by a public officer using a permit issued by the Ministry of Foreign Affairs under the Circular No. 210(III) of 31.10.2016 and its subsequent amendments, with a Letter of Credit (LC) opened on or before 09.11.2017, and cleared from Sri Lanka Customs on or before 30.04.2018	Deducting Rs. 5.0 million from payable duty or As specified in the <i>Gazette Notification</i> No. 1992/29 dated 10.11.2016 and its subsequent amendment of <i>Gazette Notification</i> No. 2027/7 dated 11.07.2017 whichever is desired by the permit holder
