The Order made under Section 2A of Value Added Tax Act, No. 14 of 2002, as amended by Act, No. 06 of 2005 and published in the Extraordinary Gazette Notification No. 2124/3 dated May 21, 2019 is hereby repealed with effect from June 01, 2019.
