SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of commodities specified in Column I of the Schedule hereto the Special Commodity Levy, at rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of one year commencing from May 18, 2021, subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette* Notification No. 2202/44 of November 21, 2020 is rescinded with effect from May 18, 2021.
