SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of one year commencing from March 04, 2021 subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.
