SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mahinda Rajapaksa, Minister of Finance of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rate specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 06 months commencing from October 27, 2020, subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the Extraordinary Gazette Notification No. 2186/32 of 31.07.2020, the Extraordinary Gazette Notification No. 2191/26 of 03.09.2020 in respect of Fish and the Extraordinary Gazette Notification No. 2184/53 of 18.07.2020 in respect of Maldive Fish are rescinded with effect from October 27, 2020.
