SRI LANKA EXPORT DEVELOPMENT ACT, No. 40 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14 of the Sri Lanka Export Development Act, No. 40 of 1979, I, Dr. Bandula Gunawardana, Minister of Trade, with the concurrence of the Minister of Finance, do by this Order amend the rate of CESS specified in the corresponding entry in Column IV in the Schedule to the *Extraordinary Gazette* No. 2202/6 dated 17.11.2020, in respect of the articles described under the H. S. Codes as specified in the Schedule hereto, with effect from 12th January, 2022.
