Order under Section 10A

By virtue of the powers vested in me under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act No. 83 of 1988, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this Order levy on imported goods specified in Column I of the Schedule hereto, a surcharge at the rate specified in the corresponding entry in Column II on the Customs Import Duty, both General and Preferential basis with effect from June 01, 2023 until December 31, 2023.

The Order made under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act No. 83 of 1988, and published in the Extraordinary Gazette Notification No. 2313/35 of January 04, 2023 is rescinded with effect from June 01, 2023.
