**Circular Letter in reference to the Public Finance Circular No. 08/2019 (i) dated 19.04.2023**

Secretaries to the Ministries

Chief Secretaries of Provincial Councils

Heads of Departments/ District Secretariats

Chairmen of State Corporations, Statutory Boards and State Owned Enterprises

**Implementation of the Electronic Government Procurement (e-GP) System in Sri Lanka.**

Your kind attention is drawn to the Public Finance Circulars No: 08/2019 dated 17.12.2019 and No: 08/2019(i) dated 19.04.2023 on the above subject.

02. As outlined in the aforementioned circulars, as a measure towards enhanced transparency and successful implementation of the e- GP system, it is expected that all Procuring Entities adhere to the following requirements. Regrettably, it is noted that only a few agencies have taken action to publish the requested information. As such, you are kindly requested to fulfill this request as matter of priority. IMF enhanced financial facility also has identified this as a request to be fulfilled by the Government of Sri Lanka.

**a. Publication of Procurement Notices**

Commencing May 01, 2023, Procurement notices covering all categories with Total Cost Estimate (TCE) exceeding Rs.200 million shall publish on the e-GP Portal. This necessitates that the relevant Procuring Entities register on the e-GP portal to facilitate this process. Relevant information is available on [www.Promise.lk//?p=front\\_cont&a=circular](http://www.Promise.lk/?p=front_cont&a=circular).

**b. Publication of Contract Awards**

Effective from July 01, 2022, details of contract awards exceeding Rs.200 million must be made available on the e-GP Portal. The responsibility for publishing this information lies with the relevant Procuring Entities, who must also be registered on the e-GP portal.

03. I earnestly request your immediate attention to this matter. I kindly urge you to ensure the publication of Procurement Notices and Information on Contract Awards on the e-GP Portal, in accordance with the dates specified in the circular (May 01, 2023, for Procurement Notices and July 01, 2022, for Information on Contract Awards).

04. You are further informed in the future, power to appoint Project Committees and Technical Evaluation Committees by the Department of Public Finance, adherence these publication requests set out under (a) and (b) above will be essentially examined.
