CASINO BUSINESS (REGULATION) ACT, No. 17 OF 2010

BY virtue of the powers vested in me by the Section 4 of the Casino Business (Regulation) Act, No. 17 of 2010, read with Section 3 of the aforesaid Act, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies hereby amend the Casino Business Licensing Regulation No. 1 of 2022, published in the *Extraordinary Gazette* No. 2295/10 dated August 31, 2022, as amended by the *Extraordinary Gazette* Notification No. 2366/33 dated January 12, 2024, by the repeal of Schedule II and the substitution therefor of the Schedule hereto.
