Government Notifications

REVENUE PROTECTION ORDER No. 06/2023

Revenue Protection Act, No. 19 of 1962

ORDER

BY virtue of the powers vested in me under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this Order from January 06, 2024, require the Director General of Customs do demand and levy on each article specified in Column 3 of the Schedule hereto at the preferential rate of the customs import duty, which is leviable and payable under the Sri Lanka - Singapore Free Trade Agreement, set out in the corresponding entry in Column 4 of that Schedule as an integral part of the Schedule "A" of the Customs Ordinance (Chapter 235).

Customs import duty at the general rate, set out in the corresponding entry in Column 5 and preferential rates, *except the preferential rate of customs import duty under the Sri Lanka - Singapore Free Trade Agreement which have been revised above*, set out in the corresponding entry in Column 4, which are leviable and payable on each article specified in Column 3 of Schedule "A" of the Customs Ordinance (Chapter 235), published in the *Extraordinary Gazette* No. 2324/49 dated March 24, 2023 as amended, including its Schedules are continued to remain in force without change.

The Schedule "A" of the Customs Ordinance (Revenue Protection Order No. 03/2023), published in the *Extraordinary Gazette* No. 2354/04 dated October 16, 2023 is hereby rescinded effective from January 06, 2024 without prejudice to any action performed under the same during its validity period.
